- Our SAFE Program, "Single Agency Fee Experience," ensures our clients do not have to pay another agency fee should their first cycle result in no viable embryos. Please note, this applies if you move forward with your same donor or a first-time donor. Some other restrictions may apply
- Donor Program costs fluctuate depending on donor compensation, expense reimbursement, or travel costs, which will vary based on your donor's location in relation to your IVF clinic. Our experienced coordinators can discuss your specific needs and our different programs to fit your budget and provide you with an accurate quote

Surrogacy Program

Our surrogacy department coordinators are committed to your journey and want to ensure the process runs smoothly. They work in pairs to ensure efficiency and accuracy throughout the process and handle all steps from the matching phase, to pregnancy, through the birth and post-birth.
